Receiving care is an essential right and tool to ensure the well-being of children in all aspects of their current and future life. Quality care, bonding relations and a stable caregiving structure around them are the basis for a child's development and the achievement of many of their rights. Despite the importance of this right, investing in care systems that protect and support the rights and well-being of caregivers and care receivers are often neglected in international and national policies.

Resolution [A/RES/77/317](#) establishes the 29th of October as the International Day of Care and support. To celebrate this key date SOS Children's Villages and partners are organizing an event to further the conversation, collect good and successful practices, listen to the voices of the constituencies and share new data and policy recommendations with the goals of improving care systems and practices.

During the event, SOS Children's Villages' [Global Report on Children's Care and Protection 2024](#) will be launched. The lead researchers will share the findings of extensive and participatory research with over 1.100 participants across eight countries on the factors driving the separation of children from their families and provide recommendations for governments and stakeholders to prevent it through integrated care and support systems.
